It is derived by dividing the aggregate income of a particular group by the total population in that group.</p> <p>*Total # of ECCE sites include all licensed sites in the city of Richmond. Out of 111, 70 accept public funding (VQB5 sites). Based on VQB5 data pulled September 2024.</p> <p>*ECCE capacity is based on licensed capacity (# of slots they are allowed to have) for centers and family day homes. For public schools, capacity is estimated based on current enrollment. Not all centers/day homes are at full capacity due to worker shortage.</p> <p>* The Head Start number does not include the other localities that are covered by the grant held by Richmond City: Powhatan (17) and Petersburg (137). The Richmond slots are broken down by 3&4 year old slots (580) and Early Head Start (56). Head Start provides slots for both Richmond City Public School and 6 Community Providers including: 5th St. Baptist, Friends, Oak Grove Fairfax and Oake Grove II, Robert Taylor and Woodville.</p> <p>* VPI slots include the total for both 4-year-olds (452) and 3-year-olds (219).</p> <p>* There are a total of 11 MD sites in Richmond City. Out of the 282 slots, 56 of those slots are infant/toddler.</p> <p>*VPI, HS, and MD slot numbers are pulled from FY24/25 Virginia Department of Education Allocations.</p> <p>*Child Care Subsidy Program slot numbers based on FY24 pulled in October 2023.</p> <p>* Pre-k experience includes Head Start, VPI, other public preschool, private preschool/daycare.</p> <p>*Publicly funded sites are public schools, sites that receive Child Care Subsidy, and sites that accept at least one public funding stream (Head Start, Virginia Preschool Initiative, Mixed Delivery, and Child Care Subsidy).</p> <p>* 90% of the brain is developed by age 5.</p> <p>* Virginia Quality Birth to Five (VQB5) measures and helps improve the quality of all publicly funded birth-to-five classrooms and supports families to choose quality programming across program types. Measures of quality are based on interactions and curriculum.</p>
